CIDB/SIRIM/MISIF Task Force SWAM's Collaborative Approach

A follow-up meeting of CIDB-SIRIM-MISIF-SWAM Task Force which was held virtually back in January 2022 has yielded some positive outcome as a result of SWAM's intervention.

MISIF has mooted & proposed for the inclusion of industry specialist to be involved in CIDB Enforcement Activiti's of which SWAM has responded in writing and unanimously objected to it citing issues of indirect intervention, and severe conflict of interest if the so called industry specialist join in to the enforcement team which is downright unethical.

Moving forward, a meeting has been scheduled in mid-July 2022 for further discussion in tandem with Act 520 aspirations where an in-depth discussion on the future direction of the Purpose Made Fabric (PMF) adoption by all industry stakeholders.

MITI/MSI - SWAM's Down Stream Voice

Under the Ministry of International Trade & Industry (MITI) initiatives, the Technical Committee of Malaysia Steel Council (TCMSC) in which SWAM has actively participated in, will meet with representatives from the upstream to downstream associations (MSA, MISIF, MSMDA, FMHMBA) together with officials from MITI together with MSI in facilitating the meeting to discuss various matters concerning industry policy-making, regulatory as well as trade matters amongst others. A major task for SWAM was our involvement in developing a white paper on Malaysia's Iron & Steel policy which we have successfully completed in 6 months back in year 2019.

Minimum Wage Impact


With rising material cost coupled with the recent Minimum Wages Order, it has not only increased the manufacturing cost but it has become increasingly difficult to even employ let alone the rise.
